Dr. Marqueza Reyes is a disaster risk reduction expert, resilience leader, consultant, trainer, and academic with extensive experience in urban and regional planning, climate adaptation, environmental management, and sustainable development across Asia.

She holds a Doctor of Engineering in Urban Planning (magna cum laude) from the University of Kassel in Germany, a Master of Arts in Urban and Regional Planning, and a Bachelor of Science in Geology from the University of the Philippines.

Prior to teaching at AIM, Dr. Reyes served as technical advisor to various multilateral organizations including the ASEAN Secretariat, the UN Office for Disaster Risk Reduction, the Asian Disaster Preparedness Center, and Earthquakes and Megacities Initiative. She has led and managed large-scale regional programs such as the ASEAN Disaster Risk Financing and Insurance Program and the ADB-Oxfam GB Urban Climate Change Resilience Project.

Currently a consultant to the Philippines' Climate Change Commission, Dr. Reyes led her team in securing the country's first-ever climate change adaptation project approved by the Green Climate Fund. She has also taught in Miriam College and the University of the Philippines and continues to support local government units across the country in land use planning and disaster risk reduction initiatives.
