



Planning and Feasibility Assessment of Development Projects

Overview

The Planning and Feasibility Assessment of Development Projects course provides a comprehensive foundation in project management principles and practices for development initiatives. It covers key aspects of project identification, design, formulation, and feasibility assessments to ensure sustainable and effective project implementation.

Participants will gain an in-depth understanding of the project cycle, examining the distinct characteristics of each stage. The course emphasizes the Design and Monitoring Framework and introduces the Logical Framework Approach as a strategic tool for project design and management. The analytical phase includes Stakeholder Analysis, Problem Tree Analysis, Objectives Tree Analysis, and Alternatives Analysis, followed by the planning phase, which focuses on developing the Logical Framework.

The second part of the course explores Project Feasibility and Appraisal, guiding participants through feasibility assessments in various development contexts. Topics include Economic Analysis with an emphasis on Cost-Benefit Analysis, Institutional Analysis Framework, Legal Analysis, Environmental Analysis, and Social Analysis Frameworks. Additionally, project simulation exercises and case studies will enhance participants' understanding of multidimensional analysis demonstrating feasibility assessments.




Objectives

At the end of the course, students will be able to:

1. Discuss the steps in the project management cycle.
2. Explain concepts and approaches in identifying and designing development projects.
3. Formulate detailed project design and plan for sustainable development projects.
4. Design project proposals that meet the standards of international organizations, funding agencies, donors, etc. and their roles in the preparation and implementation of projects and programs.
5. Apply the concepts and considerations of Economic Analysis in Project Feasibility Assessment.
6. Formulate the steps of pre-assessment activities, the assessment proper and post-analysis activities of Environmental, Social, Legal, and Institutional Assessment Frameworks.
7. Formulate Social Marketing Plan.

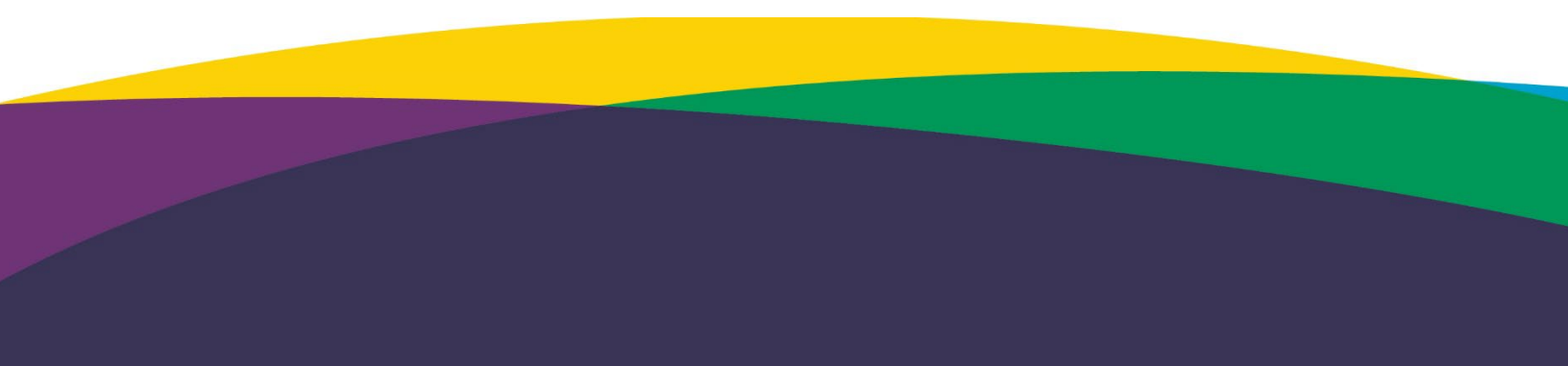

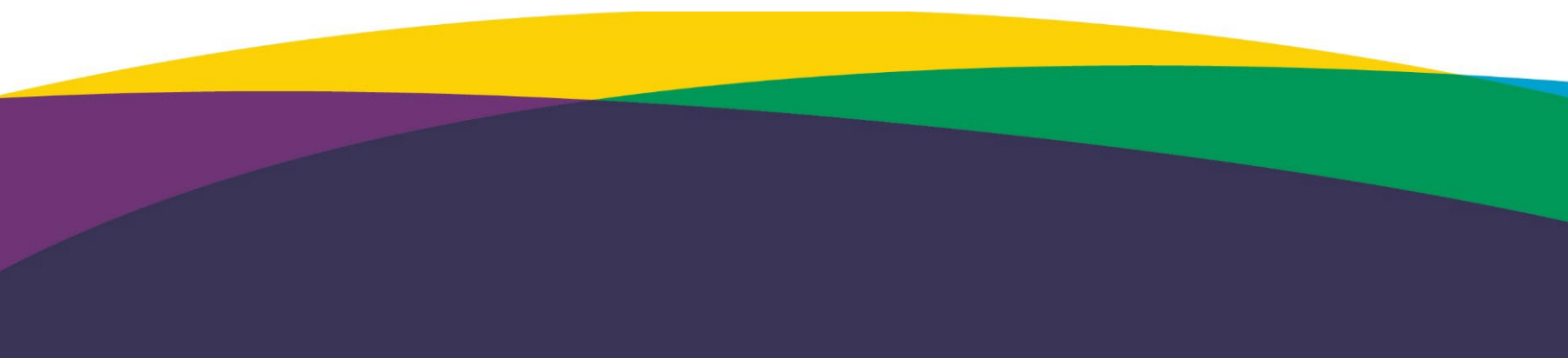
